2. Accordingly, sealed quotations are invited for the disposal of said vehicles on the terms and conditions mentioned below. Interested parties may submit their quotations in the enclosed Performa. The quotations addressed to the undersigned in a sealed cover should reach this Ministry by 11.00 A.M on 29<sup>th</sup> September, 2009. The quotations will be opened at 11.30 AM on the same day i.e. 29<sup>th</sup> September, 2009. The quotations in a sealed cover should reach the Ministry of Mines, Room No. 312, 'D' Wing, 3<sup>rd</sup> floor, Shastri Bhawan, New Delhi. The cover should prominently be superscribed with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE".

3. The quotations will be opened in Room No. 312, 'D' Wing, Shastri Bhawan, New Delhi. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotation.

4. The sale will be governed by the following conditions:

- i) The bidder is required to pay Earnest Money of Rs. 5000/- for each vehicle separately payable by means of Demand Draft drawn in favour of Pay and Accounts Officer, Ministry of Mines, New Delhi.
- ii) Quotations received without demand draft towards Earnest Money will not be accepted.
- iii) The successful bidder will be required to deposit the bid amount by means of cash/demand draft drawn in favour of Pay and Accounts Officer, Ministry of, New Delhi within two working days of the acceptance of the bid.

- iv) The Earnest Money of the successful bidder will be released only after the deposit of sale proceeds, Earnest Money will be forfeited if he fails to honour the bid.
- v) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Ration card/Voter identity Card/Passport in case of individual and Registration Certificate in case of firms etc.
- vi) The sold vehicles will be removed by the successful bidder within two days of depositing the money at their own expenses.
- vii) The vehicles will be disposed of on “as is where is basis” and no guarantee for its worthiness or quality will be given by this Ministry.
- viii) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The Ministry will not be responsible for any lapse on his part in this regard.
- ix) The bidders will not be allowed to withdraw their bids.
- x) The undersigned reserves the right to accept or reject any/all of the quotations without assigning any reason.
